3. purposes for which personal data are processed:

Personal data is processed for the implementation of the membership relationship (e.g. invitation to meetings, collection of contributions, organisation of sports activities). Furthermore, personal data will be forwarded to the regional associations for participation in competitions, tournaments and games.

In addition, personal data in connection with sporting events, including reporting on these events, shall be published on the website of the association, in the association's appearances in social media as well as on the websites of the professional associations and transmitted to local, regional and national print media.

4. legal basis on which the processing takes place:

As a rule, the processing of personal data is carried out on the basis of necessity for the performance of a contract in accordance with Article 6 (1) (b) DSGVO. The contractual relationships are primarily the membership relationship in the club and the participation in the games of the professional associations.

If personal data is collected without the processing being necessary for the fulfilment of the contract, the processing is based on consent pursuant to Article 6 (1) a) in conjunction with Article 7 DSGVO. Article 7 DSGVO.

The publication of personal data on the internet or in local, regional or national print media is done to protect the legitimate interests of the association (cf. Article 6 para. 1 lit. f) DSGVO). The legitimate interest of the association is to inform the public by reporting on the activities of the association. In this context, personal data including pictures of the participants are published, for example, in the context of reporting on sporting and social events of the association.

5. the recipients or categories of recipients of the personal data:

Personal data of members who participate in the games and competitions of the state professional associations are passed on to the respective state professional association for the acquisition of a licence, a scorecard, a player pass or other entitlement to participate.

6. the duration for which the personal data will be stored or, if this is not possible, the criteria for determining the duration:

The personal data will be stored for the duration of the membership. Upon termination of membership, the categories of data are retained in accordance with the legal retention periods and then deleted. Certain categories of data are stored in the association archive for the purpose of the association's chronicle. 7. the data subject shall be entitled to the following rights under the conditions set out in each of the articles:

- the right to information in accordance with Article 15 DSGVO,
- the right to rectification in accordance with Article 16 of the GDPR,
- the right to erasure pursuant to Article 17 of the GDPR,
- the right to restriction of processing pursuant to Article 18 of the Regulation,
- the right to data portability pursuant to Article 20 of the GDPR,
